Approval of Meeting Minutes: February 22nd, 2023

Because of a lack of quorum, there was no approval of minutes. Approval of the February 22nd, 2023 meeting minutes was tabled for the April meeting.

Regional Plan Update

Salvador Morales, LCPC Planner, guided the Committee through the Regional Plan, Public Safety: Background & Inventory and Culture & Community Strategy sections.

The Regional Plan Committee recommended the following changes to these sections:

Public Safety: Background & Inventory

Page 270:

- Not all Lamoille Towns have a Constable. For example, Wolcott does not have a constable. Constables now require formal training. Check with other towns on this and revised the language on page 270.
- Make sentence about E-911 phone exchanges clearer. Remove “for phone exchanges” in the in the last sentence of the 5th paragraph. Also revise this paragraph to match the service areas map.
- Have there been any updates to LCSD in regard to plans for expansion?

Page 271:

- First paragraph check with Eric Dodge. Is there still a Troop A based out of Morrisville?
- Last paragraph check which Emergency Rescue Squad service to confirm which one covers Elmore. Does Elmore receive EMS from Morristown, not Hardwick? Revise this ph. as appropriate.

Page 274: Table 5-1

- Remove “Railroad” from table 5-1.
- Under Drought in the table note “springs drying up” under the most vulnerable description.

Culture & Community: Strategy

Page 279:

- In first paragraph, 2nd to last sentence, revise to say “A map of resources discussed is found at the end of this chapter.”

Due to a lack of quorum Sal will follow up with the Regional Plan Committee and provide time at the beginning of the April meeting for those not present to share thoughts on the Public Safety chapter and Culture and Community Strategy. Sal will resend an invite for the remaining Regional Plan Committee meetings scheduled for the Plan update.
